Corporate Membership Contract (membership evaluated yearly)

The corporate membership has no initiation fee when these standards are met.

1. A minimum of four (4) memberships must be maintained at all times - maximum of 8 per corporate.
2. Each membership is currently \$150.00 for a single full playing membership (\$275 for a family).
3. MLGC will include 2 golf carts for the Corporate members only.
4. Corporate members may bring guests, their guests would be responsible for 1/2 of the cart fee.
5. This is a non-revolving membership, each member must be an employee of the licensed LLC.
6. Each member under this application will have full member privileges at all times.
7. The corporate member will be set up on auto payment paid on or near the 15th of each month.
8. If a resigned corporate member wishes to return less then 90 days of resignation will be charged \$350 reinstatement fee.

If the corporate membership is full, other Membership options will be available with no initiation fee.

Basic Rules of Participation

1. Tee times must be made by pro shop staff and must be made 24 hours in advance.
2. Players must rent a ½ cart per person from the host facility
3. Charging privileges should be allowed.
4. Guest privileges will be allowed but all other guests not from a participating club must pay the existing host club greens fee rate.
5. Players must adhere to all rules at the host facility.
6. The host club will maintain total control of available tee times.

MOSES LAKE GOLF CLUB DRESS CODE

All male members and male guests must wear collared shirts or golf appropriate attire while on the golf course.

T-shirts, tank tops, or gym attire will not be allowed.

Jeans are acceptable during all playing months, however they must not be torn or tattered.

All women members and women guests may wear appropriate non-collared shirts. Sleeveless golf shirts are acceptable or other golf appropriate attire.

Attire and grooming shall not be such as to generally offend other Members or their guest. Members are responsible for seeing that their guests conform to dress codes. Golfers who are not in compliance with the dress code will be asked to change into appropriate attire before play.

This will be at the discretion of the Pro Shop staff.

BILLING POLICY

- Statements are sent on the first day of the month and account payment in full is due by the 15th of the month.
- An account that carries a balance over 30 days will incur a monthly 1.5% finance charge (*18% per year*).
- An account with a balance over 60 days will have charging and club privileges suspended until account is paid in full.
- An account with a balance over 120 days could have membership terminated and may be turned over to collections.

MEMBERSHIP CHANGE POLICY

- Membership changes will be effective on the date written request for the change is received by the business office.
- An additional fee of \$250 will be charged to change from Family to a Single full play membership.

RESIGNATION POLICY

- Membership resignation will be effective on the date written notice is submitted to the business office and account balance is paid in full.
- Resigned member account(s) with an outstanding balance will continue to incur a monthly 1.5% finance charge (*18% per year*) until payment in full is received.
- If a resigned member wishes to return within six months of resigning, payment of back dues or the initiation fee (whichever is greater) will be required before reinstatement.

RETURNED CHECK POLICY

- A \$30.00 charge will be assessed for any returned checks.
