If payments are overdue by the end of the month, the credit card on file will be charged for the outstanding balance on approximately the 5th day of the following month. We offer an Auto Payment option with a 3% merchant fee for those who choose to pay their membership in this manner.

I acknowledge that accounts that are past due will incur a finance charge of 1.5% per month. If my credit card is declined, Moses Lake Golf Club may suspend my membership privileges due to the delinquent amount on my account. I agree to pay all actual attorney fees and costs if my account is sent for collection.
